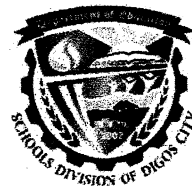

Salutations!

In 2011, President Benigno C. Aquino signed into law R.A. 10157 institutionalizing the Kindergarten Education into the Basic Education Program of the country. The main premise of this law is to provide equal opportunities for all children to avail of accessible mandatory and compulsory kindergarten education that effectively promotes physical, social, intellectual, emotional, and skills stimulation and values formation to sufficiently prepare them for formal elementary schooling. Due to this law, there is now a need to retool our day care and Kindergarten teachers and coordinators in order to fine tune their knowledge that is, generally, within the bounds of the K to 12 framework and specifically is in conjunction to the Kindergarten Framework so that there is a seamless connection of the Day Care curriculum and Kindergarten curriculum to the primary grades. Through this, learners will not feel any form of cultural, pedagogical, and intellectual shock when they enter grade 1.

In conjunction to this, JBOGM Tutorial, Review and Training Services Co. will be conducting a **3-day International Seminar-Workshop on "Thematic Approach: Lesson Planning and Managing the Kindergarten Classroom"** (see attached program and profile of international and national resource speakers and facilitators). This training will equip the kindergarten teachers in preparing lessons and the learning environment that meet the needs of the 5-year old learners while preparing them for primary education. Furthermore, this training will also help the Kindergarten coordinators to monitor the kinder classrooms promptly within the bounds of the principles of teaching and learning in the early childhood years.

Registration fee is set at **Php4,000 for onsite registrants** and a discounted fee of **Php3,700 for early bird registrants** which should be deposited 15 days before the training schedule (pls. see attached program for the list of bank accounts). The fee is inclusive of 3 lunches, 2 snacks (AM/PM), certificate, CD's containing the training materials and professional fees and honoraria of the resource speakers. Accommodation is not included in the registration but we will assist the participants for their accommodation needs.

I hope that this project merits your approval and endorsement to your kindergarten teachers and coordinators in your Division. I am looking forward to working with you in improving the lives of the people within your care through quality education (*please see attached DepEd Advisory*).
