**DEPLOYMENT OF PUBLIC SCHOOLS DISTRICT SUPERVISORS (PSDSs) TO PRIVATE EDUCATIONAL INSTITUTIONS FOR THE CONDUCT OF MONITORING and EVALUATION and the PROVISION OF TECHNICAL- ASSISTANCE**

1. As an offshoot to the capacity building initiatives provided to Public Schools District Supervisors (PSDSs)/District Coordinating Principals (PICs) last November 25-26, 2016 on the operational guidelines in the granting of government authority to private educational institutions, this Regional Office directs all Schools Division Offices to ensure their immediate deployment with close supervision by the concerned SDO focal person, to private schools within their area of responsibility for the conduct of monitoring, evaluation and provision of technical assistance.

2. To ensure purposive and guided activity, PSDSs/ PICs are required to utilize the herein attached *Quality Assurance Monitoring and Evaluation Tool for Private Educational Institutions* in their school visitations.

3. Moreover SDOs are reminded to ensure strict compliance to the provisions of Regional Memorandum 226, s. 2016 (excluding item numbers 5 and 6). Attention is requested to item no. 7 of the said Regional Memorandum directing the submission of a consolidated SDO report to this Regional Office: Attn: Quality Assurance Division every first week of the second month of every quarter.
