

1. In pursuance to DepEd Order No. 8, s. 2015, re: Policy Guidelines on Classroom Assessment for the K to 12 Basic Education Program, this Office informs the field of the unified preparation of test questions for Periodic Exams starting Calendar Year 2018.

3. The final List of Test Writers per level and per subject area, as well as the template for the preparation of Table of Specification (TOS), is hereto attached.
4. The following should be taken into consideration in the preparation of test questions:
 - a) Paper size – must be set at 13 inches long in the computer
 - b) No. of Test Items: Kindergarten – 25 items; Gr. 1 to 10 – 40 items
 - c) Test Items Classifications and Percentages for Gr. 1-10:
 - c.1 Knowledge Level – 30% (12 items)
 - c.2 Understanding/Comprehension Level – 40% (16 items)

c.3 Higher Level (Application, Analysis, Synthesis, Evaluation) – 30% (12 items)

5. Test writers are expected to bring with them samples of test materials for 3rd Periodical Test and copies of CG during the aforementioned meeting. They are also advised to bring with them their own snacks/lunch.
6. Moreover, in consideration to time element seeing to it that test questions for 3rd Periodical Test are ready by December 20, the agreed date among Supervisors for its availability, test writers are advised to start formulating test questions ready for submission to the focal EPS/designated personnel one week before December 20, 2017. Each test writer is expected to submit a 40-item test, while the focal EPS shall finalize the test in consideration to submitted test questions from all test writers.
