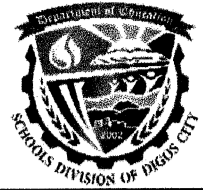

2017 Division Science and Technology Fair

1. In support to the programs and activities of the Department of Education and in pursuance to the conduct of the 2017 Regional Science and Technology Fair (RSTF), this Office through the Education Program Supervisor in Science will conduct the 2017 Division Science and Technology Fair on November 9, 2017, 7:30 AM to 5:00 PM at Digos City National High School, Rizal Avenue, Digos City.
2. The Division Science and Technology Fair aims to promote Science and Technology consciousness among the youth and identify the most creative/innovative and the best Science researchers who will represent the Division in the 2017 RSTF.
3. The Science Investigatory Project categories to be contested and the number of contestants per event are as follows:

Categories	Number of Contestants
Physical Science- Individual	Top three (3) winners at the school level Science Fair
Physical Science - Team	Top three (3) winners at the school level Science Fair (maximum of 3 members)
Life Science – Individual	Top three (3) winners at the school level Science Fair
Life Science - Team	Top three (3) winners at the school level Science Fair (maximum of 3 members)

4. All entries must adhere to the Intel International Science and Engineering Fair Rules and Guidelines 2018, both for the preparation of manuscript and the display board.
5. The participants to this activity are the project proponents, coaches, event facilitators, judges, and members of the working committees.
