AND GUIDELINES ON THE IMPLEMENTATION OF THE
UNIVERSAL KINDERGARTEN EDUCATION PROGRAM
Re: Continued Use of National Kindergarten Curriculum Guide
(NKCG)

1. This Division Memorandum No. ___s.2016 is hereby issued to the field to reiterate significant stipulations relevant to the continued use of National Kindergarten Curriculum Guide (NKCG).

2. Enclosure No. 1 to DepED Order No. 21, s.2012 dated March 2012, letter E. Curriculum and Training, paragraphs 1.1.1, 1.2 clearly stipulate which thus read as follows:

1. The Kindergarten Education Program (KEP) shall continue to use the following curriculum materials:

1.1. Standards and Competencies for Five-year old Children. "This material contains standards and competencies expected of a 5-year old children along the different domains for growth and development. This should also serve as guide for teachers in tracking the development of children along each of the seven domains".

1.2. National Kindergarten Curriculum Guide (NKCG). "This contains daily learning activities developed in thematic integrated manner for all the four(4) grading periods. Teachers should familiarize themselves with the learning activities to ensure that they are able to use them to develop the competencies. Although there are learning materials such as stories and games included in the NKCG, teachers are encouraged to add or localize the activities, they believe can be best taught using local resources.

3. Significantly, the Class Program of the Kindergarten classes conforms to the National Kindergarten Curriculum Guide (NKCG) to maximize the various domains, competencies, and learning activities of the children within the given period of time.

4. Attached is a sample Kinder Class Program for all Kindergarten teachers to implement.

5. 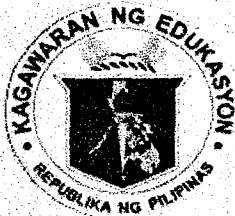

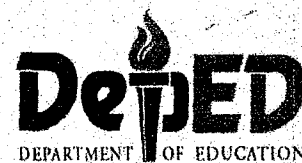
