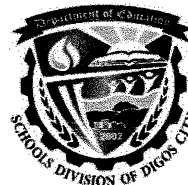

RE-SCHEDULING OF DATE OF PANAGTIGIAY 2017

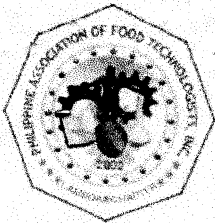
