CIVIL SERVICE COMMISSION'S PRE-RETIREMENT COUNSELING SEMINAR

- 1. DECS Order No. 28, s. 2001 authorizes this Department/Division to disseminate information on suggested competitive events, scholarship and training opportunities for our teachers, students and pupils. These are issued as ADVISORIES, purely for field information. Participation is on the basis of personal judgement, time and resources.
- 2. This has reference to the enclosed letter from the Regional Office of the Civil Service Commission (CSC), dated June 21, 2019, regarding its offer of a Pre-Retirement Counseling Seminar scheduled on July 10-12, 2019, at a venue to be announced later.
- 3. Aside from information on the benefits that the retiring employees are expecting from their membership with the GSIS, SSS, PHIC and PAG-IBIG upon their retirement from government service, the seminar shall also discuss approaches to positive mental attitude, opportunities for investment or recreation and other topics relevant to retirement.
- 4. Qualified participants to this seminar include:
 - a) Would be retirees (i.e., employees who will be retiring within 5 years);
 - b) Administrative Officers/HRMO's/designates who are tasked to assist would-beretirees in the preparations of the required documents; and
 - c) Interested employees who are 50 years old and above.
- 5. This seminar is non-residential, and a fee of six thousand pesos (P 6,000.00) shall be collected from each participant.



The Civil Service Commission, in its task to assist government personnel to cope effectively with retirement, will conduct the Pre-Retirement Counseling Seminar (PRCS) on July 10-12, 2019 at a venue to be announced later.
