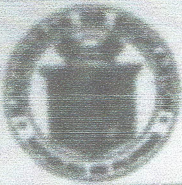

The Department of Education through the Bureau of Learning Delivery -Student Inclusion Division (BLD) will be conducting the NTOT on SPED on January 15-19, 2018 at Piazza Zicarelli Hotel, Genu, Isabela for Luzon Cluster and on January 29 - February 2, 2018 at Punta Villa Hotel and Resort, Arevalo, Iloilo City for Visayas-Mindanao Cluster.

The number of participants per region is attached in Enclosure No. 1 for your reference and guidance. The participants are SPED Supervisors and Special Education Teachers who were writers of the SPED Handbook and who can serve as trainers shall be given priority in the regional slots. The remaining slots will be filled by other SPED Teachers who experienced being trainer at least in the division level. It is strongly advised that the selection of participants shall be distributed according to the following specialization: 1) Difficulty in remembering and concentrating; 2) Difficulty in displaying interpersonal behavior; 3) Difficulty in hearing; 4) Difficulty in seeing; 5) Difficulty in mobility; 6) Difficulty in communicating; 7) Difficulty in performing adaptive skills; and 8) Difficulty in applying knowledge. The list of participants shall be submitted using the template in enclosure no. 2 through email address blt.sid@deped.gov.ph or fax no. (02) 631-9993 not later than 1-week before the activity.

The first meal to be served for Luzon Cluster is dinner of January 14, 2018 and the last meal will be pm snack of January 19, 2018 while the first meal to be served for Visayas-Mindanao Cluster is dinner of January 28, 2018 and the last meal will be pm snack of February 2, 2018.

Travel expenses, and per diems of participants shall be charged against local funds, while board and lodging and other incidental expenses shall be charged against 2017 BEC funds.
