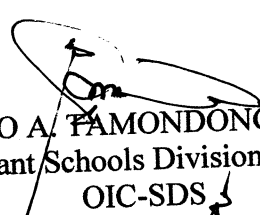

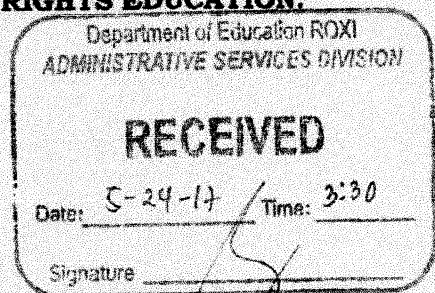

The Teachers' Dignity Coalition will hold the **National Seminar-Workshop on the Magna Carta for Public School Teachers, Public Sector Unionism, and Human Rights Education: A Teachers' Summer Camp** with the theme *Rights and Responsibilities for Teacher and Child-Friendly Schools* from May 25 to 27, 2017 at the Aringay Central Elementary School, DepEd Division of La Union, Aringay, La Union.
