RE Training Workshop On Contextualizing SGOD Support Systems for IP Education**

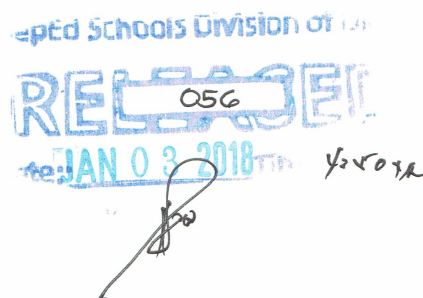

The Enhanced Basic Education Program, as stipulated in Republic Act 10533 and the IPEd provision of its IRR (sec8.4) mandates DepEd to develop a curriculum that is culture-sensitive, contextualized, and flexible enough to enable and allow schools to localize, indigenize, and enhance based on the specific educational and social context of communities.
2. As the organization under the level of the Schools Division Office which is in-charge of providing educational support services, it is imperative that the School Governance Operations Division (SGOD) and its personnel are cognizant of their duties and functions in ensuring the successful implementation of contextualized IPEd education.
3. In view of the foregoing, all concerned are hereby directed to attend the training on December 26 – 28, 2017 at a venue to be arranged (TBA) later.
4. The training objectives include the following:
 - a. To discuss the legal and policy basis of the IPEd Program including foundational concepts that guide program implementation;
 - b. To discuss the accountabilities and functions of the SGOD in relation to the process of IPEd implementation;
 - c. To identify the key governance issues and concerns that need to be addressed in support of curriculum contextualization for IPEd;
 - d. To analyze the governance issues and concerns raised, and discuss appropriate interventions;
 - e. To discuss and give feedback regarding policies supportive of governance concerns in IPEd implementation;
 - f. To design tools as needed for SGOD concerns; and
 - g. To formulate an action plan specific on governance concerns in IPEd implementation.
4. Attached is the list of participants (Enclosure 1). Accommodation, food, travel and other incidental expenses of the participants shall be charged to the IPEd Program Support Fund 2017 (Supplemental), subject to the usual accounting and auditing rules and regulations.
