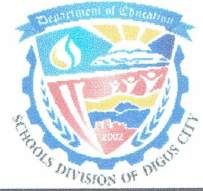

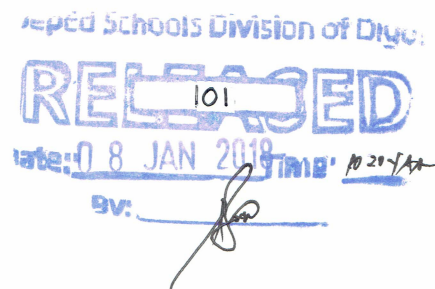

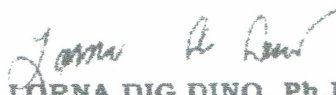

DATE : **December 12, 2017**

1. This refers to the subject activity to be held on January 10, 2018 at Grand Regal Hotel, Davao City.
2. The National IPEd Gathering organized by the DepEd - Indigenous Peoples Education Office (IPsEO) is an opportunity to affirm the milestones and gains of the IPEd Program while strengthening DepEd's partnership with indigenous cultural communities (ICCs) and civil society partners particularly for curriculum development and education planning. For this particular gathering, the IP Education Program shall commemorate ten years of dialogue with ICCs (2008-2017) while opening the second decade of dialogue (2018-2027).
3. Aligned with our strategy of sustained engagement with key stakeholders, the National IPEd Gathering shall gather more than a hundred representatives of indigenous peoples (IP) communities/organizations, IPEd advocates, support groups/non-government organizations (NGOs), and DepEd Regional and Division IPEd Focal Persons who have a stake in strengthening multi-sectoral support for DepEd's IPEd Program.
