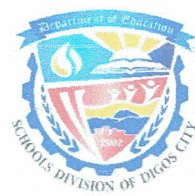

REGIONAL MEMORANDUM CIRCULAR NO. 11-05 s. 2017

TO: ALL HEADS OF AGENCIES IN REGION XI
SUBJECT: 2018 SEARCH FOR OUTSTANDING GOVERNMENT WORKERS

The Civil Service Commission announces the acceptance of nominations to the 2018 Search for Outstanding Government Workers, an undertaking under CSC's Honor Awards Program, which aims to recognize and reward state officials and employees for their outstanding contributions and achievement in the delivery of public service.

The Search covers three (3) award categories, namely: the Presidential Lingkod Bayan Award, the Outstanding Public Officials and Employees or *Dangal ng Bayan* Award, and the Civil Service Commission Pagasa Award.

The award categories are described as follows, viz:

1. **Presidential Lingkod Bayan Award** - is given to an individual or group of individuals whose contribution had a nationwide impact to public interest, security and patrimony. The contribution may be a suggestion, innovation, invention or a superior accomplishment.
2. **Outstanding Public Official and Employees Award or the Dangal ng Bayan Award** - is conferred on an individual for performance of an extraordinary act or public service and consistent demonstration of exemplary ethical behavior on the basis of his/her observance of the eight norms of behavior which is provided under Republic Act No. 6713, otherwise known as "Code of Conduct and Ethical Standards for Public Officials and Employees".
3. **CSC Pagasa Award** - is conferred on an individual or group of individuals for outstanding contribution/s resulting from an idea or performance that directly benefit more than one department of the government.

Heads of agencies, and state workers are enjoined to actively participate in the search and submit nominations. The guidelines, as provided in CSC Resolution No. 1600111, as well as the forms and other materials may be downloaded at www.csc.gov.ph.
