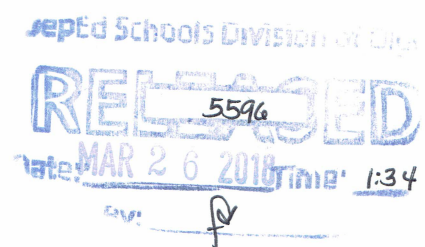

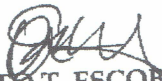

Dear **Atty. Escobarte**:

The City Government of Davao is in receipt of a letter from the Professional Regulation Commission (PRC) informing us of the Licensure Examination for Teachers (LET) in Davao City on March 25, 2018, the same day as the Ironman 70.3 International Triathlon that will involve road closures from Davao del Norte to Davao City.

In this regard, we strongly request that you disseminate the information on the road closures to schools and review centers, so that the LET examinees may be guided accordingly.

To assist examinees from Northern Mindanao, the City Government of Davao will be deploying buses to ferry them from specific points going to Davao City. All buses will depart at 3:30am at the following pick-up points:

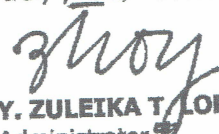
Location	Number of Buses	Pick-up Point
Tagum City	2	Jollibee, Daang Maharlika Highway cor. Apokon Road
Carmen	1	In front of the Carmen Municipal Hall, Daang Maharlika Highway
Panabo City	1	Below Panabo Overpass, Daang Maharlika Highway

May we also suggest that you devise a way to help ensure that examinees, both from within and outside Davao City, are able to get to the examination venues despite the road closures.
