4. Likewise, attached herewith is the Program Design with its Objectives and Methodology for your reference.

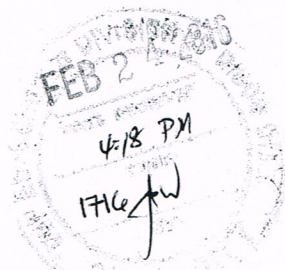

2.0 RATIONALE:
