3. Participants are advised to bring their own laptop, pocket wifi, copy of their travel authority and any significant study or research on the implementation of OHSP.

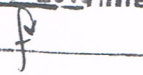

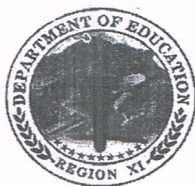

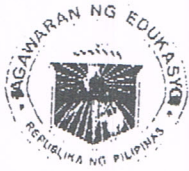
