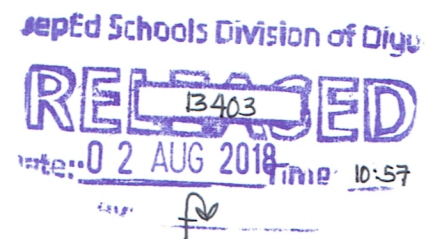

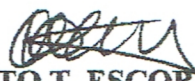

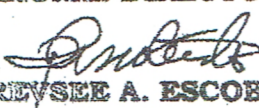

The Bureau of Learner Support Service (BLSS), through the School Sports Division (SSD), will conduct the **National Conference on Screening and Accreditation of Athletes and Coaches** from August 7 to 9, 2018 (exclusive of travel time) at the **Brentwood Apartelle** in Brentwood Village, Brgy. M. Roxas, Baguio City.

This is pursuant to Rule II, Section 8 (a) and (b) of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10588 otherwise known as the *Palarong Pambansa Act of 2013*, mandating the Palarong Pambansa Board "to formulate policies and guidelines that shall govern the conduct of Palarong Pambansa" as well as "to review and update regularly the rules and regulations of the sports in accordance with international standards."

The Conference aims to:

- a) review the policies and guidelines on screening and accreditation of athletes, coaches and chaperons;
- b) discuss legal issues on the rights of athletes to data privacy act and protection from sports and related abuses; and
- c) improve the database and documentary requirement of athletes, coaches and chaperons in relation to data privacy act.
