1. In reference to GSP Council Circular No. 2, s. 2018, the field is hereby informed of the 2-day training for Service Auxiliary Volunteers for Emergency and Relief (SAVER) on August 11-12, 2018 at Heracleo Casco Memorial High School, Sta. Maria, Davao Occidental.
2. 3. Service Credits will be granted to teachers who will attend the training and Compensatory Overtime Credits (COC) for the non teaching staff and School Commissioners in consideration to DepEd Order No. 53 s. 2003, Re: Updated Guidelines on Grant of Vacation Service Credits to Teachers.

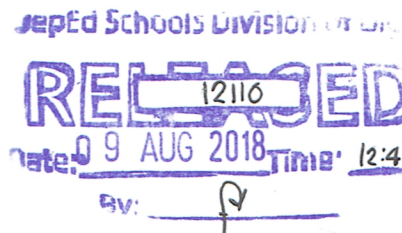

Registration fee is P 200.00 per girl and 250.00/adult for entrance of swimming pool and other expenses and needs of facilitators .

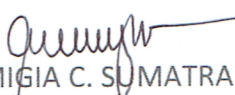
Things to bring :

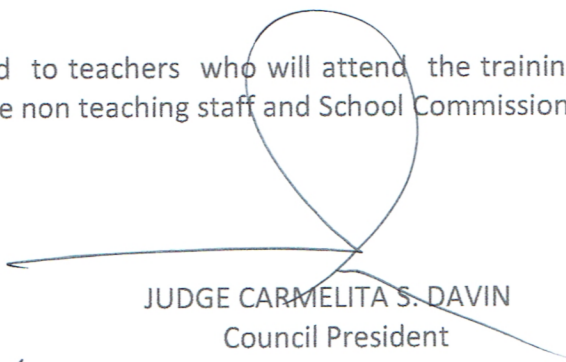
1. Food for the whole duration
