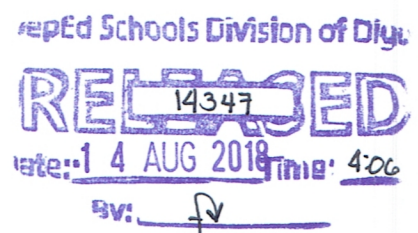

I. ACTIVITY OVERVIEW

The Department of Education, in partnership with UNICEF Philippines and Child Protection Network Foundation, Inc., will be conducting a **National Child Protection Summit** with the theme "Strengthening the implementation of the Child Protection Policy" on August 23-24, 2018 at SMX Convention Center, Pasay City.

The Summit aims to gather DepEd teaching and non-teaching personnel, as well as partners and stakeholders from various government and non-government agencies to discuss strategies that will strengthen the implementation of the Child Protection Policy (CPP) at the school level. This is anchored in the following sub-objectives:

- For the participants to gain insight on the issues in implementing the policy by examining existing studies and other efforts to monitor CPP;
- For the selected experts and child care practitioners to share their insights on the vulnerabilities that children encounter;
- For the partners to share promising practices on child protection;
