Consistent with its mandate to protect and promote the right of all citizens to quality basic education, the Department of Education (DepEd) is finalizing the revised manual of regulation of private schools in basic education which shall guide DepEd offices across governance levels, private schools and other stakeholders in the exercise of the Department's authority over private schools towards the achievement of education outcomes

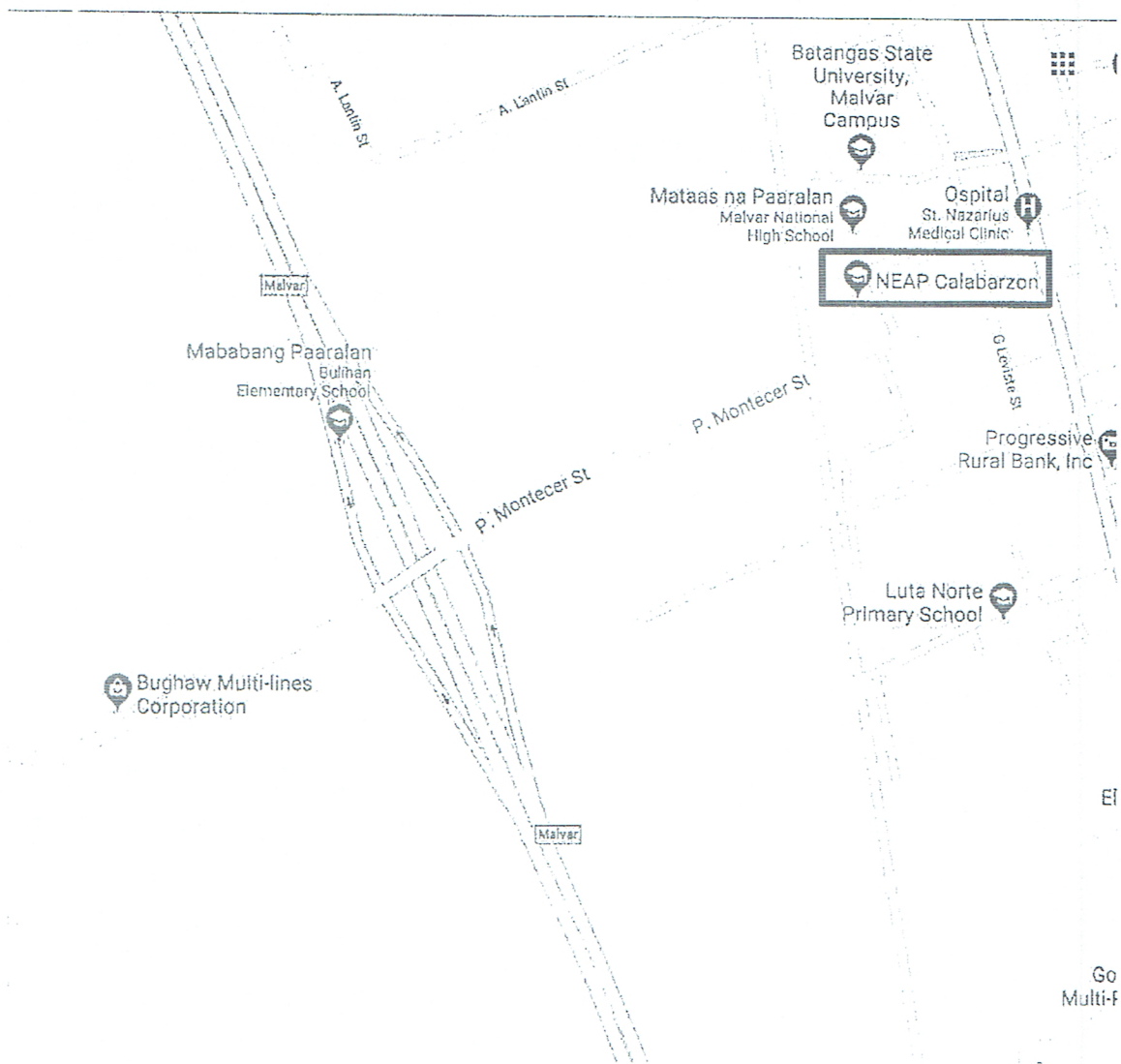
