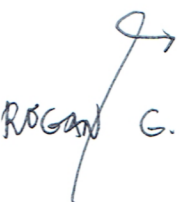
**DEPLOYMENT STATUS OF TEACHER I POSITIONS IN
GOMA NATIONAL HIGH SCHOOL**

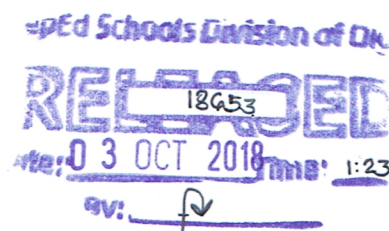
To: **MR. ROGAN G. ADANZA**

1. Pursuant to the 1st Indorsement dated July 9, 2018 of Atty. Alberto T. Escobarte, CESO III, Regional Director, Department of Education Regional XI Office, Davao City, the Notice of Organization, Staffing and Compensation Action (NOSCA) was referred to this office for publication and filling-up purposes. The said NOSCA created fourteen (14) Teacher I Position for Junior High School Batch 1 for SY 2018-2019 distributed as follows: Eight (8) for Dawis National High School; and, Six (6) for Goma National High School.
2. Upon inquiry of the Administrative Officer V of this Office with the Department of Budget and Management (DBM), the DBM focal person for this Office told him that the Teacher I position for Dawis National High School and Goma National High School did not belong to the Digos City National High School. Further, he was informed that, since Dawis National High School and Goma National High School are not **Independent Units**, the deployment of the said Teacher I Positions shall be under the direct supervision of the Officer-In-Charge of the Office of the Schools Division Superintendent. Thus, the DBM downloaded the said Teacher I Positions in the PSIPOP of this Schools Division Office.
3. The teachers in your school per NOSCA was appointed in the month of August with specific **Assignment Orders** issued by the undersigned that they shall report and teach in Goma National High School. These teachers shall derive their salaries from this Office after submitting pertinent documents issued by the said school.
4. In view thereof, the Office of the Schools Division Superintendent would like to inquire from your good end on the status of their deployment.
5. Should there be changes made in their deployment order without the knowledge of the undersigned, you are hereby enjoined to explain within five (5) from receipt of this order on the changes made and the circumstances surrounding therein
6. For immediate dissemination and strict compliance.
