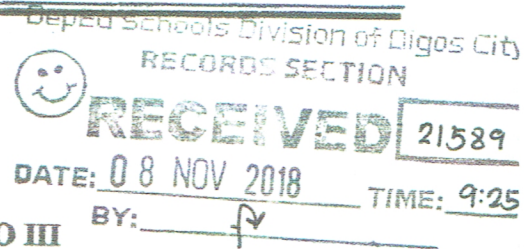

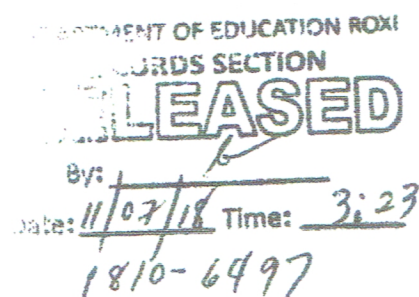

With reference to DepEd Memorandum No. 158, s. 2018, the 2018 Principals' Test will be administered nationwide on December 9, 2018 in various regional testing venues.

As of October 16, 2018, deadline of online application, the Principals Test Online Application System (PTOAS) has generated a total number of 23,123 applicants. Thus, this Office shall no longer accept online applications.

Taking into consideration online applications with incomplete documents, please be informed of the following revised cut-off dates for immediate compliance:

Deadline	Activity
October 31, 2018, 12 midnight	End of "For Compliance" in the evaluation and validation of documents
November 6, 2018, 12 midnight	Submission of requirements for those applicants with pending documents "For Compliance"
November 7, 2018, 12 midnight	Evaluation of applications by the SDO Evaluators
November 9, 2018, 12 midnight	Validation of Applications by the RO Validators
November 12, 2018, 8 PM	Payment of Examination Fee
November 13-19, 2018	Release of the Final List of Examinees and Assignment of Testing Venues through a Regional Memorandum
