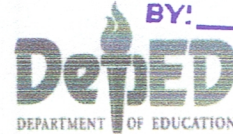

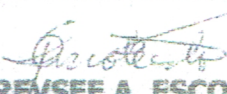

1. In its effort to upgrade the competencies of Special Games/Events coaches and technical officials, the Bureau of Learner Support Services – School Sports Division (BLSS-SSD) will conduct the National Training on Sports Coaching and Officiating for Student with Disability in Baguio City from December 4 – 7, 2018.
2. The objective of this training is to capacitate and enhance the knowledge and the skills of public school teacher – coaches and technical officials in the science and art of sports coaching and officiating for student with disability. The training shall cover various general topics such as: Athletes Classification, Strength Training and Conditioning, Sports Nutrition, Child Protection Policy and Data Privacy Act.
3. A total of twenty (20) participants per region, preferably public school teacher-coaches, trainers and technical officials who would best represent their regions. The Regional Sports Officers shall recommend participants who did not attend the two trainings, Pangkat Malakas held in Baguio City and Pangkat Maliksi held in Lingayen, Pangasinan to give opportunity to other coaches and technical officials to avail this capacity building activity. Upon registration, participants shall be required to submit the following:

For Coaching Participants

- a) Certification from the school principal or from the Division Office that he/she has at least three (3) years coaching experience and is presently coaching a SPED team;
- b) Has at least basic knowledge on handling para-athletes; and
- c) Medical certification from a government physician that he/she is medically and physically fit. Participants who are pregnant are not advised to attend the training.

For Officiating Participants

- a) Certification from the school principal or from the Division Office that he/she has at least three (3) years officiating experience;
 - b) Has at least basic knowledge on handling para-athletes; and
 - c) Medial certification from a government physician that he/she is medically and physically fit. Participants who are pregnant are not advised to attend the training.
4. Furthermore, participants are required to bring their personal sports supplies and equipment (e.g. whistle) and to wear proper attire during the conduct of the training.
 5. Participants are requested to be in the venue on December 3, 2018. The first meal to be served on December 3 will be dinner and the last meal will be lunch of December 7, 2018. The regional sports office shall be informed of the final venue for the accommodation.
 6. Expenses for this training such as board and lodging, training kit, honoraria/professional fee for resource speakers, travelling expenses of management staff and resource speakers, office supplies and other incidental expenses shall be charged against the 2018 Physical Fitness and School Sports Competition funds subject to usual accounting and auditing rules and regulations. However, travelling expenses of participants shall be charged against local funds.
 7. The Regional Office shall submit their recommended list of participants to the School Sports Division not later than November 15, 2018. The required number of participants per sports and region are contained in the enclosure.
