March 29, 2019 (Friday) – May 12, 2019 (Sunday)	Appointment or hiring of new employees, creation or filling up of new positions, promotion or giving of salary increases remuneration or privilege (Sec. 261 (g), OEC) Release, disbursement or expenditures of public funds (Sec. 261 (v), OEC) Construction of public works, delivery of materials for public works and issuance of treasury warrant or similar devises for a future undertaking chargeable against public funds (Sec. 261 (w), OEC)
