SUBJECT: Cybersafety in Schools Training for Regions IX and XI

DATE: January 23, 2019

Pursuant to DepEd Memorandum No. 94, s. 2016 on "Protection of Online Child Protection and Prevention of Cyberbullying", the Department of Education (DepEd) advocates for the protection of all children from online abuse, exploitation, and bullying through the use of the Cybersafety Lesson Plans for Grades Five to Six and Junior High School. Developed in partnership with Stairway Foundation, Inc. (SFI), the lesson plans aim to develop children's capacities on how to be safe online, teach positive online behavior, and address safety issues as they navigate the online world.

To further the advocacy, the DepEd and SFI developed additional lesson plans for Grades One to Four and designed a training program for teachers and Division personnel on the use of the Cybersafe Lesson Plans.

Thus, the **Cybersafety in Schools Training** for Regions IX and XI will be conducted on February 27-March 1, 2019 in Grand Regal Hotel, J.P. Laurel Avenue, Lanang, Buhangin, Davao City.

Participants to this training shall come from all Division Offices of Regions IX and XI and shall be composed of the following personnel:

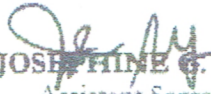
- One (1) personnel from the School Governance and Operations Division, specifically, the personnel in charge of Human Resources;
- One (1) Elementary School Master Teacher on *Edukasyon sa Pagpapakatao*; and
- One (1) Secondary School Master Teacher on *Edukasyon sa Pagpapakatao*.

Participants who have successfully completed the training shall be designated as Trainers on Cybersafety and are expected to cascade their learnings from the training to the respective Divisions. Thus, we request that the Division select participants who are familiar with the Internet and social media and have the expertise and leadership skills to train other school and Division personnel.

All Divisions are requested to submit the names of their participants on or before **February 11, 2019** using the attached Confirmation Slip through email at childprotection@deped.gov.ph.

The DepEd participants' travel and other incidental expenses shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
