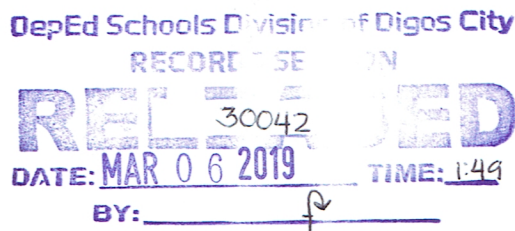
The IBP aims to gather 2,500 lawyers, including those in the government service, to discuss important issues and concerns affecting the legal profession.
