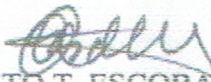

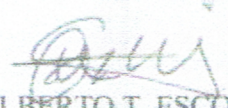

SUBJECT : **MISUSE OF NAMES OF DEPED REGIONAL OFFICIALS**

1. The Regional Office has received feedback from the field about unscrupulous traders misusing or name-dropping the names of the Regional Office Staff to gain business transactions with DepEd Division Offices and public schools using the MOOE fund.
2. The undersigned has invariably observed the policy not to get involved or intercede in any financial transaction by a certain businessman or business entity with the division offices or school as the same is improper, irregular and illegal act. This has always been my work ethics and I intend highly to maintain that way.
3. People who are misusing or name-dropping any name shall be reported immediately to the Regional Office. Traders misusing my name or any of the Regional Staff should also be banned immediately from further transactions with DepED Division Offices or public elementary and secondary schools.
