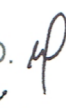

**Conduct of the Division Training on Senior High School
Competency-Based Learning**

**To: Chief Supervisor- CID & SGOD
School Principals/Officers-in-Charge
Public Senior High Schools**

1. The DepEd Digos City Division, through the Curriculum Implementation Division (CID), will conduct the Division Training on Senior High School (SHS) Competency-Based Learning (CBL) on April 29-May 2, 2019, at Matti National High School, Matti, Digos City.
2. The training has the following objectives:
 - a. Reorient the SHS teachers on the SHS Framework
 - b. Capacitate SHS teachers on teaching strategies and approaches essential to teaching-learning process.
3. Attached is the List of Participants to the said training.
4. The registration fee of participants shall be chargeable against Division/School MOOE subject to the usual accounting and auditing rules and regulation.
5. Teacher-participants are entitled to service credits for the services rendered on the duration of the training while non-teaching personnel are entitled to compensatory overtime credits (COC) for services rendered during holidays. Such privileges are in accordance with DepEd Order No. 53, s. 2003 on "Updated Guidelines on Grant of Vacation Service Credits to Teachers", and with Civil Service Circular NO. 2, s. 2004 on "Non-Monetary Remuneration for Overtime Service Rendered".
6. Participants are requested to bring laptop, extension cord, pocket wi-fi, copies of the curriculum guides, and other materials such as manila paper, masking tape, marking pens, scissors, and bond paper which shall be used during workshops.
7. Further, teacher-trainers and facilitators shall convene on April 25, 2019 at Matti National High School to prepare the venue and training materials and will have a walk-through of the topics assigned to each. Teacher-trainers and facilitators shall be entitled to service credits for the services rendered during the conference and the duration of the training as per DepEd Order No. 53, s. 2003 on "Updated Guidelines on Grant of Vacation Service Credits to Teachers."
