The Department of Education through the Bureau of Learning Delivery-Student Inclusion Division (BLD-SID) will conduct the **Training of Grades 2 and 8 Receiving Teachers on SPED Content and Pedagogy on May 6-9, 2019 for the Luzon Cluster** and on **May 21-24, 2019 for the VisMin Cluster** at a venue to be announced later. The activity aims to capacitate the regular or receiving teachers on content and pedagogy of the different disabilities to ensure that inclusive education will happen in the classroom. Also, the training program aims to improve the attitude of participants towards learners with disabilities.

The expected participants in this activity are regular or receiving teachers (one (1) grade 2 and one (1) grade 8 per division) who did not attend any training program on the different disabilities or special education; willing to share the acquired knowledge and skills with his/her colleagues in the division or school during Learning Action Cell sessions; and willing to accept and handle learners with disabilities in his/her regular class (See attached allocation on the number of teachers allotted per Region).

Travel expenses of participants shall be downloaded to the regional offices, while board and lodging and other incidental expenses of participants and the management team shall be charged to the program funds, subject to the usual government accounting and auditing rules and regulations. However, the downloading of funds for the travel expenses of participants requires an acceptance letter signed by the Regional Director or his/her authorized representative. The acceptance letter shall be sent to BLD-SID on or before April 5, 2019 to ensure the immediate processing of the downloading of funds.
