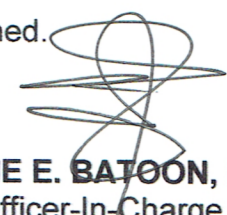

SCHOOL-BASED ECOLOGICAL SOLID WASTE MANAGEMENT

To: SGOD and CID Chiefs
Public Schools District Supervisors (PSDS)
School Heads, All Public and Private Elementary and Secondary Schools

Attention : YES-O Moderators and Assistant Moderators

1. Pursuant to Republic Act (R.A.) No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000; Republic Act (R.A.) No. 9512, entitled "*An Act to Promote Environmental Education and for Other Purposes*"; DepEd Order No. 93, s. 2011 entitled "Mandated PPAs and Targets pertinent to the YES Program", and in consonance with the recently conducted Consultative Meeting with the Local Government Unit (LGU), headed by Hon. Josef F. Cagas – City Mayor of Digos, held last August 13, 2019 at Ramon Magsaysay Central ES, this Office requires all Schools to submit their Action Plan/Program on Solid Waste Management Program. This action plan shall include the following:
 - a. Integration of Environmental awareness and Solid Waste Management in the curriculum during the entire month of September;
 - b. Closely Monitoring the School Canteen to discourage vendors and operators in using single-use plastic utensils or materials and the like;
 - c. Encouraging Pupils/Students to minimize using and bringing of materials made of plastic; and
 - d. all other concrete initiatives that may be implemented in school to reduce solid wastes.
2. The action plan, using the attached template, shall be the basis for monitoring and shall be submitted to the School Governance and Operations Division (SGOD) of the Schools Division Office, Attention: Ms. Julie Anne N. Posadas, Division YES-O Coordinator, or through email address: julianne.posadas@deped.gov.ph on or before **September 15, 2019**. Further, the best implementing school on the solid waste management program will be awarded before the end of the school year. Guidelines and mechanics for the said award will be in the subsequent Division issuance.
