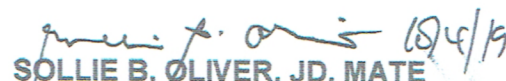

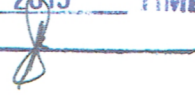

The objectives of this conference are:

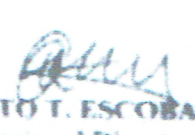
- To promote and support the professional development and growth of male and female teachers and non-teaching personnel
