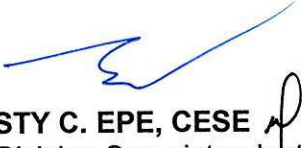

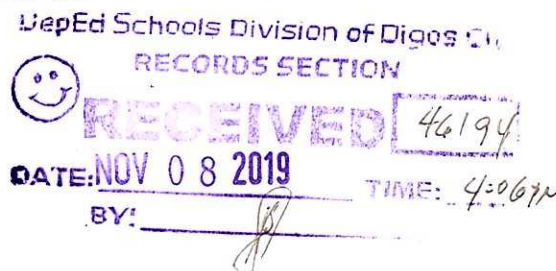

In line with Republic Act 10679, an Act promoting entrepreneurship and financial education among Filipino youth, the Bureau of Curriculum Development (BCD) seeks to enhance the curriculum standards through strengthening the entrepreneurship curriculum contents that specifically focus on the development of life skills, career development skills, entrepreneurial skills, and leadership skills.

This goal aligns itself to the main goals of K to 12 education which is to prepare SHS learners to be part of the productive workforce and to provide viable exit option as entrepreneurs. Entrepreneurship as a life skill and as a career, is seen to help the youth with life challenges in school, in own community and country.

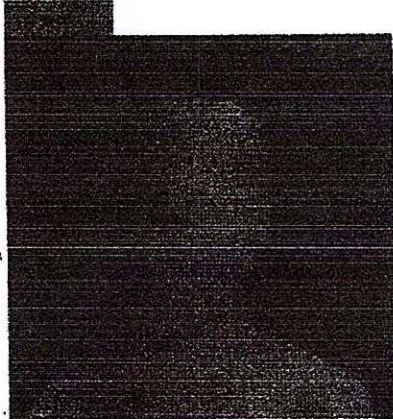
