The Department of Education (DepEd) Central Office issued DepEd Memorandum No. 21, s. 2020 entitled "**Second Set of Policy Directives of the DepEd Task Force nCoV**", to provide further information and guidance to DepEd officials, personnel and staff at the Central Office, regional offices (ROs) and schools division offices (SDOs) and schools nationwide, relative to the ongoing efforts of the Department to respond to the novel coronavirus acute respiratory disease (2019-nCoV ARD) which is now renamed as Coronavirus Disease (COVID-19).

It is reiterated that all policy directives and measures contained in DepEd Memorandum No. 15, s. 2020, titled "**First Set of Policy Directives of the DepEd Task Force nCoV**" are sustained.

The following measures are further reiterated and elaborated:

- a. **The travel measures and restrictions as stipulated in Enclosure No. 2 to DM 15, s. 2020, remain in effect.** Further, all personnel and learners who decide to proceed with their scheduled personal travels for the month of February to countries identified to have confirmed cases of 2019-nCoV shall be subjected to **mandatory self-quarantine for 14 days** from the date of arrival in the Philippines. The 14 days of self-quarantine of DepEd personnel shall be charged to their leave credits, while the learners on self-quarantine shall be provided with alternative delivery modes (ADM) of education;
- b. **The suspension of all national and regional activities** involving learners and/or teachers requiring travel and congregation of various schools, divisions, and/or regions, and of **all off-campus activities for the month of February 2020**, as stipulated in Enclosure No. 2 to DM 15, s. 2020, **remain in effect.**

Enclosure No. 3 to DM 15, s. 2020 specifies that schools shall coordinate with SDOs, LGU and health authorities for the suspension of classes, if necessary. Following the advice of the Department of Health (DOH), regional director (RD), schools division superintendent (SDSs), and/or school heads are authorized to suspend classes, based on the conditions below as stipulated in Enclosure No. 1:

- a. If one school has confirmed one positive case of 2019-nCoV ARD, the school head can declare the suspension of classes;
- b. If two or more schools in one city or municipality have confirmed a positive case of 2019-nCoV ARD, the SDSs can declare the suspension of classes in the affected schools and adjacent areas or depending on the local situation in the entire city or municipality;

- d. If there is community level transmission in two or more provinces, RDs can declare suspension of classes in the affected provinces or depending on the local situation in the entire region;
- e. All schools division offices (SDOs) are required to report all class suspensions to the Disaster Risk Reduction and Management Service (DRRMS) through drmo@deped.gov.ph, copy furnished our Project Development Officer II (DRRM) in the regional office, Mr. John Arnel Villacorte (john.villacorte@deped.gov.ph).

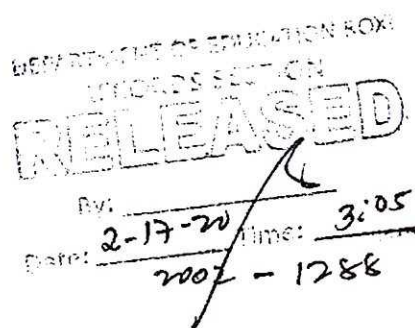

SUBJECT: Interim Guidelines on 2019 Novel Coronavirus Acute Respiratory
Disease (2019-nCoV ARD) Response in Schools and Higher
Education Institutions

I. BACKGROUND

After a cluster of pneumonia cases of unknown etiology was reported in Wuhan City, Hubei Province of China last December 31, 2019, Chinese health authorities preliminarily identified the cause of this viral pneumonia as a new or novel type of coronavirus (2019-nCoV).

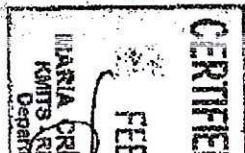
With an increasing number of cases spreading to various territories and confirmed human-to-human transmission, the World Health Organization declared the outbreak as a Public Health Emergency of International Concern (PHEIC) last January 30, 2020.

The Department of Health (DOH) hereby issues interim guidelines for public and private schools and higher education institutions (HEIs) to prevent, contain, and mitigate the transmission of 2019-nCoV ARD in schools and HEIs.

II. GUIDELINES

To effectively manage and address the threat of the 2019-nCoV ARD in Schools and HEIs, the following strategies are strongly encouraged:

A. General Preventive Measures



- i. Teach students and staff to cover their mouth and nose when coughing and sneezing with tissue or their shirt sleeve, to properly dispose of used tissues in trash cans, and to immediately wash their hands thereafter.
 - ii. Provide adequate supplies within easy reach, including tissues, no-touch trash cans, and soap.
 - iii. See *Annex A* for respiratory etiquette.
- b. Encourage hand hygiene among students and staff through education, scheduled time for handwashing, and the provision of supplies.
 - i. Teach students and staff to wash hands often with soap and water for 20 seconds, dry hands with a paper towel, and use the paper towel to turn off the faucet. If soap and water are not available, and hands are not visibly dirty, an alcohol-based hand sanitizer containing at least 60% ethanol or isopropanol may be used.
 - ii. Include handwashing time in student schedules.
 - iii. Provide adequate supplies, including clean and functional handwashing stations, soap, paper towels, and alcohol-based hand sanitizers.
 - iv. See *Annex B* for proper handwashing technique.
- c. Encourage students and staff to keep their hands away from their nose, mouth, and eyes.
 - i. Encourage routine surface cleaning through education and school policies.
 - ii. Tidy and clean surfaces and objects that are touched often, such as desks, countertops, doorknobs, computer keyboards, hands-on learning items, faucet handles, and phones. Empty trash cans as needed.
 - iii. Use general cleaning products following product label directions. Additional disinfection beyond routine cleaning is not recommended.
 - iv. Provide adequate supplies, such as general FDA-registered cleaning products, gloves, disinfecting wipes, and no-touch trash cans.
- d. Encourage students and staff to avoid contact with animals and avoid consumption of raw or undercooked animal products.
 - i. Handle raw meat, milk or animal organs with care, to avoid cross-contamination with uncooked food, as per good food safety practices.
 - ii. Do not slaughter sick animals for consumption. Bury or destroy dead animals and avoid contact with their body fluids without protective clothes.

iii. When visiting live animal markets, wet markets or animal product markets:

- a. Practice general hygiene measures, including regular hand washing with soap and potable water after touching animals and animal products
- b. Avoid touching eyes, nose or mouth with hands
- c. Avoid contact with (a) sick animals or spoiled animal products (b) other animals possibly living in the market (e.g., stray cats and dogs, rodents, birds, bats) and (c) potentially contaminated animal waste or fluids on the soil or structures of shops and market facilities

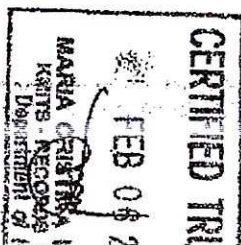
2. Infection Control

- a. Preventive actions to stop the transmission and spread of the virus
 - i. Encourage learners and staff to stay home when sick.
 - ii. Advise learners, parents, and staff on the importance of staying home when sick for at least 24 hours after they no longer have signs and symptoms (fever or signs of a fever, cough, colds).
 - iii. Review school policies on:
 - a. Implementing flexible sick leave policies for students and staff.
 - b. Lifting the use of perfect attendance awards.
 - c. Cross-training staff so that others can cover for co-workers who need to stay home.

B. Management of Symptomatics

1. Advise/orient learners, parents, and staff on the signs and symptoms of 2019-nCoV ARD, emergency warning signs (difficulty of breathing), and high-risk groups (individuals with other existing medical conditions).
 - i. Those who would manifest fever and/or respiratory infection and have a history of travel from China or contact with a sick household member who had a history of travel from China for the past 14 days, should consult the school clinic and be referred to the nearest hospital with prior notification. Transportation needs should be coordinated with the Barangay Health Emergency Response Team (BHERT).
2. While waiting for referral and transport of sick individuals, separate learners and staff with fever and respiratory infection from others preferably in a well-ventilated holding area with handwashing facility or sink with soap and water, alcohol-based hand rub, tissue paper, and no-touch trash can. Provide masks to the sick learner/staff with proper instruction. (Annex C)

C. Community Engagement and Coordinated Response



The decision of school officials for the temporary suspension of classes and activities should be based on the result of the joint risk assessment. Resumption of classes and activities will follow the same procedure.

2. Administrators must immediately notify the Barangay Health Emergency Response Team (BHERT) of II (a) symptomatic (b) asymptomatic with history of travel to China and (c) asymptomatic with history of exposure PUIs for 2019-nCoV ARD.

- a. A PUI is any individual who exhibits symptoms consistent with the 2019-nCoV ARD and has history of travel to affected areas or close contact with a caregiver of a PUI or a confirmed case of 2019-nCoV ARD.

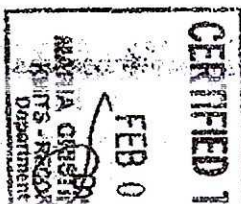
D. Declaration of Class Suspension by Response Level

1. Confirmation of cases, as well as community-level transmission, shall only come from the DOH. At any Response Level (*Annex D*), the Local Chief Executive (LCB), can declare class suspensions as deemed fit based on information or recommendation provided by DOH. In cases where urgent action is needed, the school administrator can declare class suspension and inform the LCB thereafter, in accordance with prescribed actions for Response Levels.
2. Lifting of school suspensions or deactivation of Response Levels III and IV, may be made 10 calendar days from the date of suspension of classes provided that students, faculty, and non-teaching personnel with 2019-nCoV ARD symptoms, PUIs, or confirmed cases remain isolated at home or at designated health facilities.
3. Prior to resumption of classes, schools must undertake the following:
 - a. General cleaning of the school
 - b. Disinfection of chairs, desks, doors, toilets, lavatories, and garbage bins with cleaning material
 - c. Ensure provision of water, soap, and other supplies for proper hygiene
 - d. Intensify campaign for hand and respiratory hygiene and general sanitation
4. Prior to resumption of classes, Local Health Authorities must:
 - a. Ensure compliance of the school on the actions to be taken by the school prior to resumption of classes
 - b. Provide assistance in the provision of health services related to the prevention and control of 2019-nCoV ARD
 - c. Intensify campaign for hand and respiratory hygiene and general sanitation

DEPARTMENT OF HEALTH ADVISORY ON USE OF MASKS

The public is enjoined to judiciously use masks to prevent the shortage of surgical masks and N95 masks.

1. People in good health do NOT need to use face masks.
2. Use of surgical face masks is ONLY recommended for:
 - a. Persons caring for the sick
 - b. Persons with respiratory infection/symptoms coughing, sneezing, and/or have fever
 - c. Healthcare and other frontline workers (e.g. BI, PNP)
3. N95 masks must be reserved for healthcare and other frontline workers who are:
 - a. Attending to patients with respiratory infection/symptoms (cough, colds) or patients under investigation
 - b. Entering rooms of PUIs or confirmed nCoV patients to provide care or clean/disinfect the environment, or obtain clinical specimens (note: with complete PPE)
 - c. Handling clinical specimens, soiled medical supplies or equipment, or come in contact with potentially contaminated environmental surfaces

In all settings, masks should be used in combination with frequent hand hygiene with alcohol-based hand rubs or soap/water.
