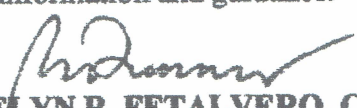

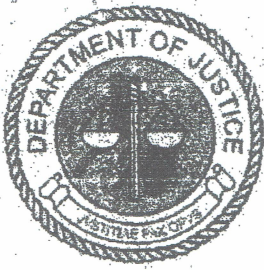

Corollary thereto, we would like to issue the following invitations to your office:

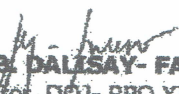
