In pursuance to the RM 051, s. 2020 entitled "Monitoring on the Performance Tasks for SY 2020-2021 Private School Learners Amid the National Health Emergency due to Pandemic", the 2020 Oplan Balik Eskwela Monitoring, and the observations from the local government units in Region XI that confirmed the presence of learners in the streets or outside of their homes during class hours despite the conduct of classes amid the imposition of health and safety protocols due to the national health emergency and the threat of high incidence of COVID-19 which is mostly caused by local transmission, this Division Memorandum is hereby issued to this effect.
2. In line with its commitment to ensure teaching and learning continuity while following the imposed health and safety protocols, this Schools Division Office remains committed to the realization of the policy of the Convention of the Rights of the Child obliging governments to take measures to encourage regular attendance in school and reduce drop-out rates of learners.
3. Following strict health and safety protocols, private schools are encouraged to establish a mechanism that will strategically and randomly monitor the attendance of learners to ensure that they are at home doing their expected tasks while they are being facilitated by their parents or guardians.
4. To give utmost care and assistance to parents or guardians who will need further support in assisting their children, all private schools are further encouraged to establish a Community Help Desk.

**MONITORING ON THE PERFORMANCE TASKS OF SY 2020-2021
PRIVATE SCHOOL LEARNERS AMID THE NATIONAL HEALTH
EMERGENCY DUE TO COVID - 19 PANDEMIC**

Presidents/Directors/Principals of Private Schools
All Others Concerned

1. The 2020 Oplan Balik Eskwela Monitoring and the observations from the local government units in Region XI confirmed the presence of learners in the streets or outside of their homes during class hours despite the conduct of classes amid the imposition of health and safety protocols due to the national health emergency and the threat of high incidence of COVID-19 which is mostly caused by local transmission. On October 24, 2020 a Regional Memorandum to this effect was issued by this Regional Office for the public schools entitled "Monitoring on the Performance Tasks of Learners."
2. In line with its commitment to ensure teaching and learning continuity while following the imposed health and safety protocols, the Department of Education Regional Office XI remains committed to the realization of the policy of the Convention of the Rights of the Child obliging governments to take measures to encourage regular attendance in school and reduce drop-out rates of learners.
3. Following strict health and safety protocols, private schools, technical and vocational institutions, higher education institutions including state and local universities and colleges offering K to 12 Basic Education are encouraged to establish a mechanism that will strategically and randomly monitor the attendance of learners to ensure that they are at home doing their expected tasks while they are being facilitated by their parents or guardians.
4. To give utmost care and assistance to parents or guardians who will need further support in assisting their children, all entities mentioned in the preceding paragraph are further encouraged to establish a Community Help Desk.
5. Schools Division Superintendents are directed to closely coordinate with the above-cited institutions for the provision of technical assistance.

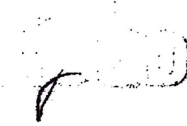
