In support of the Council for the Welfare of Children (CWC) and its celebration, together with the other government agencies and the whole nation, of the **30th National Children's Month (NCM)** this November 2022, the Department of Education (DepEd), through its Child Rights in Education Desk (CREDe), will be **virtually conducting the Fourth National Summit on the Rights of the Child in Education on November 26, 2022 from 8:00 a.m. to 5:00 p.m.** with the theme, **"Pagtaguyod sa Karapatan, Kalidad na Edukasyon at Kalinga para sa Kabataang Pilipino."**

The 30th NCM's focus and theme for this year tackles the mental health and well-being of children. Likewise, as with the previous Summits, there will be a **Pre-Summit Conference for Learners on November 19, 2022** to elicit the learners' views and suggestions on the Summit design and to prepare them for participation and involvement in the Summit.

The Fourth Summit will again be conducted virtually within the Zoom platform where we will be joined by different officials and personnel from the DepEd offices and public schools, and various stakeholders. More importantly, learners themselves, together with their parents and/or guardians, will also participate. We will also stream the Fourth Summit live to ensure we reach out to more viewers and wider audiences through the DepEd Philippines Facebook Page.

OBJECTIVES:

1. Reinforce the continuing commitment of the DepEd and other stakeholders in protecting and upholding children's rights in education as the nation continues to adapt to the changes and challenges brought about by the resumption of in-person classes. Further, the Summit aims to build on the gains of the 3rd National Summit on the Rights of the Child in Education held virtually last November 2021, and to reaffirm the Rights-Based Education Framework in the DepEd (RBE-DepEd) and the objectives of CREDe, as articulated under the Child Rights Policy (D.O. No. 31, s. 2022).
2. Facilitate discussions on children's rights, quality education, and mental health, among others, and to elicit recommendations on upholding RBE-DepEd as we enter into post-pandemic conditions, return to in-person classes, and other circumstances essentially through a whole-of-school, whole-of DepEd, whole-of-government, and whole-of-society approach. It shall also serve as a venue to ensure the participation of children in shaping policies and actions for consideration by the DepEd in normal times and during the COVID-19 pandemic.
3. Provide a formative and ideal opportunity to tackle issues on child rights, mental health, and quality education, as well as to revisit RBE-DepEd and the initiatives and efforts of the DepEd concerning child rights, better learning, and more possibilities for collaboration among stakeholders of child rights in education.
