With this, the Schools Division of Digos City will conduct a **Stakeholders Convergence for the Protection and Security of Children in Digos City at Arnaldos Hotel and Restaurant on February 28, 2023, 1:00pm**, which includes the Philippine National Police (PNP), City Social Welfare Development Office (CSWDO), City Local Government Operations Officer (CLGOO), Liga Vice President, PTA Federated President, 39th Infantry Battalion, President of the SGC regarding the above-mentioned incidents. All School Heads and PSDSs are hereby directed to participate in the said activity to deliberate the issues of schools in relation to the said incidents.

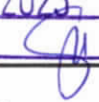
