3. For the terms of preference in the establishment of the **Learner Rights and Protection Desk**, there will be a coordination meeting to be attended by the Billeting Schools' Child Protection Policy Coordinators and Guidance Counselors/Coordinator/Designates together with the Partners Schools' Child Protection Policy Coordinators and Guidance Counselors/Coordinator/Designates as enumerated in the attached **List of Billeting Quarters and Partner Schools**. The meeting will be held tomorrow, May 30, 2023 at 3:00 o'clock in the afternoon in Don Mariano Marcos Elementary School gymnasium.

AND ESTABLISHMENT OF CHILD PROTECTION
HUB DURING THE CONDUCT OF THE 2023
RSPC AND RFOT

Date : May 22, 2023

Relative to Regional Memorandum No. CLMD-2023-214 entitled 2023 Regional Festival of Talents dated May 5, 2023, and Regional Memorandum No. CLMD-2023-220 entitled 2023 Regional Schools Press Conference (RSPC) dated May 8, 2023, which will be held on June 9-12 and June 8-11, 2023 respectively at Digos City.

In line with this, Schools Division of Digos City is requested to provide a standby medical team on 24/7 basis to cater health needs of all contingents coming from different Schools Division Offices.

Further, it is also requested that Learner Rights and Protection Hub should be established in Digos City National High School as referral point to address child protection concerns on 24/7 basis through provision of helpline. Every billeting school shall establish Learner Rights and Protection Desk which will be manned by the host member/s of the Child Protection Committee/s together with the delegation child protection in-charge.

It is suggested that the host division will source out the assistance of the Provincial Social Welfare Development Office and City Social Welfare Development Office together with the Provincial Health Office and City Health Office to facilitate referral mechanisms on health and safety concerns of all delegations.

Travelling, food, and other incidental expenses shall be charged against local funds (SDO/MOOE/LSB and other sources) subject to the usual accounting and auditing rules and regulations.
