Date : July 27, 2023

In accordance to Memorandum DM-CT-2023-194, re: Reiteration of Republic Act 8293, Section 176 or the "Intellectual Property Code of the Philippines" on the Learning Resources for National Learning Camp (NLC), this office reiterates the strict observance of the unauthorized sharing of evaluated LRs as stipulated in RA 8293 sec.176.

RA 8293 sec. 176 states that "no copyright shall subsist in any work of the Government of the Philippines. However, prior approval of the government agency or office wherein the work is created shall be necessary for exploitation of such work for profit. Such agency or office may, among other things, impose as a condition the payment of royalties".

With this, PSDSs, School Heads and School LR Coordinators are reminded that learning resource materials for NLC may only be shared to reproduction teams, participating teachers and concerned personnel from School Governance and Operations Division (SGOD) and Curriculum Implementation Division (CID).
