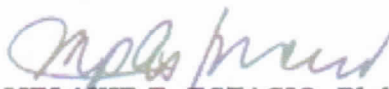

Participant to activity is the Division MEP Focal Person, Mrs. Cherry Rossette E. Oliva, Public Schools District Supervisor of Digos South District.

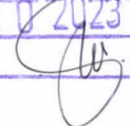

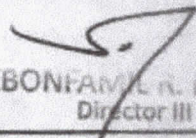
