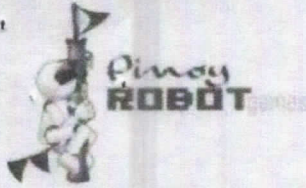

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement executed this 1st day of September, 2023 at Davao City, Philippines by and between:

DATA SCIENCE AND TECHNOLOGY CORPORATION, a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at 295 Col Boni Serrano Ave. Lot 7 Greenview Compound, Bagong Lipunan, Crame Quezon City, represented herein by its Vice President, **MR. MELVIN R MATULAC** hereinafter referred to as "PRG-NRC";

- and -

DAVAO CITY NATIONAL HIGH SCHOOL, with principal address at F. Torres Street, Davao City, Philippines, with its Principal, **MS. EVELYN E. MAGNO**, hereinafter referred to as "DCNHS"

WITNESSETH:

WHEREAS, PRG-NRC is a corporation duly engaged in the business of, among others, robotics technology and training service, design of robot games and innovation contest, design and development of systems and processes in staging the *National Robotics Competition* and several other International competitions under the brand *Pinoy Robot Games*.

WHEREAS, PRG-NRC has sole rights to the National Robotics Competition an annual event since 2008, and National Sumobot Competition, organized and executed by PRG-NRC with winners being nominated by PRG-NRC to various international robotics competitions; and all game designs, materials and processes published under Pinoy Robot Games website.

WHEREAS, DCNHS, a recognized educational leader of Science and Technology needs to nurture gifted young individuals in the field of technology, through robot games and innovation competitions that respond to pressing concerns of the community and in support of the local industries; that such events would be primarily for the service of DepEd schools and private educational institutions;

WHEREAS, DCNHS desires to stage national and regional innovation and robotics competitions using the brand of Pinoy Robot Games and National Robotics Competition; make use of processes, game materials, and systems developed by PRG-NRC in staging competitions; conduct support training for teachers and students using training materials developed by PRG-NRC.

NOW THEREFORE, for and in consideration of the foregoing premises, and the terms and conditions set forth hereunder, the parties have agreed as follows:

I. SCOPE OF WORK

- 1.1 **PRG-NRC** will design and decide on the appropriate games and competitions to be used by **DCNHS** under the National Robotics Competition on November 9, 2023, prepare the project plan, train necessary individuals from **DCNHS**, and guide in the production of the playing fields to meet standards.
- 1.2 **PRG-NRC** shall provide training and project plans for the referees, game officials and staff of **DCNHS** to successfully implement the National Robotics Competition and other satellite events. (see attached appendix "NRC2023 - Davao Detailed Plan")
- 1.3 **PRG-NRC** shall provide lodging and transportation for a maximum of 2 **PRG-NRC** personnel during the preparation and execution of the National Robotics Competition on November 9, 2023.
- 1.4 **PRG-NRC** permits the reuse or use of any robot games published in the Pinoy Robot Games website for events held in **DCNHS** with the requirement of a written notice received at least 60 days before the event. The event should acknowledge Pinoy Robot Games and **PRG-NRC** in all media materials. **PRG-NRC** reserves the right to check quality and standards of the game materials to be used in the event.
- 1.5 **PRG-NRC** shall support the **DCNHS** set of robotics trainers to build their capacity in training teachers and students with the use of the online training materials appropriate for coaches and students; **PRG-NRC** shall hold the copyright to all training and game materials and permission to use is always explicit. Certificates issued will be using both brands of **DCNHS** and **PRG-NCR**
- 1.6 **DCNHS** shall provide **PRG-NRC** the complete training documentation (for each robotics training conducted and game events), including, but not limited to, list of participants and contact details, photos of the training, and marketing materials used. Use of materials will be in accordance with existing data privacy standards.
- 1.7 **DCNHS** shall provide a venue for all the games which meets the necessary standards by **PRG-NRC**
 - 1.7.1 Gymnasium - Innovative game, opening/closing ceremony
 - 1.7.2 Conference room - Line Tracing game
 - 1.7.3 Innovation hub or similar room - Sumobot game
 - 1.7.4 Comfort room/s and Parking lot
 - 1.7.5 Sound system
 - 1.7.6 Tables and chairs
- 1.8 **PRG-NRC** shall support **DCNHS** operations by providing a donation of two thousand five hundred (2,500) pesos as a token representing an estimated computation of electricity and water consumption during the event.

II. DURATION

- 2.1 The duration of this Agreement shall be for a period of one (1) year, starting from September 1, 2023 and ending on June 30, 2024 subject to renewal upon mutual agreement of the parties.

III. VENUE

- 3.1 The National Robotics Competition 2023 shall be held at the Davao City National High School on November 9, 2023, under the leadership of DCNHS and in collaboration with the Department of Education (DepEd-Region XI).

IV. CHARGES AND FEES

- 4.1 Registration fees collected for the National Robotics Competition on November 9, 2023 shall belong to PRG-NRC. Fees collected after the event and training conducted by DCNHS shall belong to DCNHS.
- 4.2 Medals and trophies will be provided by PRG-NRC. Certificate design will be approved by both DCNHS and PRG-NRC before reproduced and distributed by DCNHS.
- 4.3 DCNHS through its list of winners elects participants to the National Sumobot Competition exclusive of registration fee.

V. RELATIONSHIP

- 6.1 Nothing contained in this Agreement shall be deemed to create any association, partnership, joint venture, or relationship of principal and agent or employer and employee between the parties hereto.
- 6.2 Neither party hereto shall have any authority to make any representation to bond one party to any promise, agreement or representation without the express written authority of the other party; and the agents, employees or other representatives of the parties hereto shall not have the right, power, or authority to bind the parties to any verbal promise, agreement or representation.
- 6.3 Neither shall an employer-employee relationship be deemed to exist between PRG-NRC and DCNHS.

VI. BINDING EFFECT

This Agreement shall inure to the benefit of and be binding upon the respective heirs, executors, successors, representatives, and assigns of the parties, as the case may be.

VII. ENTIRE AGREEMENT

The parties acknowledge that this Agreement constitutes the entire agreement between the DCNHS and PRG-NRC and completely supersedes all other prior understandings, previous communications or contracts, oral or written, between the parties relating to the subject matter thereof. This Agreement shall not be modified in any respect by any verbal statement, representation or agreement made by any employee, officer of PRG-NRC or DCNHS. Any amendment or modification thereto must be in writing and signed by the parties hereto.

VIII. SEVERABILITY

If any provision of this Agreement is determined to be invalid or unenforceable in whole or in part, such invalidity or unenforceability will attach only to such provision or part of this Agreement and the remaining part of such provision and all other provisions of this Agreement shall continue in full force and effect.
