The Department of Education (DepEd), through the Bureau of Learners Support Services- School Health Division (BLSS-SHD), issued **DepEd Order 10, s 2016 (DO 10 s 2016) or the Policy Guidelines for the Comprehensive Water, Sanitation, and Hygiene in Schools (WINS) Program** to promote correct hygiene and sanitation practices among school children and a clean environment in and around schools to keep learners safe and healthy.

DepEd, through the BLSS-SHD, in partnership with the United Nations Children's Fund (UNICEF) shall spearhead **this year's celebration of the Global Handwashing Day** with theme **"Clean Hands are within Reach."** This global advocacy is celebrated annually every 15th day of October and is dedicated to increasing awareness and understanding on the importance of handwashing with soap as an effective and affordable way to prevent disease and save lives.

In line with the celebration, a short program titled **Malinis na Kamay tulay sa Malusog at Matatag na Kinabukasan shall broadcasted via the DepEd Philippines Facebook Page on October 13, 2023 (Friday), 1:30 – 2:30 pm.** This activity aims to highlight the importance of promoting a culture of hand hygiene as critical public health measure to ensure safe schools and communities. To showcase best practices in hand-hygiene related initiatives, the event shall feature handwashing jingles with videos submitted by regions.

In this regard, each school is encouraged to submit a **30-45 second handwashing jingle** with accompanying video that highlights the importance of handwashing in the promotion of general health and prevention of the transmission of infection. Five (5) regions with the best jingles shall be selected to be broadcasted via DepEd Philippines FB page during the actual conduct of the program. In addition, a commitment video to show support of each region for the observance of the 2023 Global Handwashing Day will also be shown during the program (for details, please see attached Enclosures).

Further, all schools, particularly learners, are enjoined to participate in the said activity.

Annex B

Guidelines for Submission of Handwashing Jingles with Video of Each Region

1. The lyrics/contents of the Jingle to be submitted by each region on hand-hygiene/handwashing initiatives in the schools should revolve in answering any of the following guide questions:
 - a. Why is handwashing important?;
 - b. What benefit/s can we get with proper handwashing; and
 - c. When is the best time to practice handwashing, among others.
2. The duration of the jingle must be **30 to 45 seconds only (must not exceed 45 seconds)**;
3. Jingles should be an original composition both in tune and in lyrics. It should not violate copyright laws;
4. Jingles can be developed by learners or teachers, either individually or in groups;
5. Jingles can be in English or Filipino or a mix of both;
6. The use of offensive and discriminatory words are prohibited;
7. Any musical instrument can be used as an accompaniment;
8. For submitting the handwashing jingle with the accompanying video, the following procedures are recommended:
 - a. Subject must be positioned at the center of the frame;
 - b. Medium Shot (from the top of their head to roughly their waist) is recommended;
 - c. Give at least an inch for the head room for the subject;
 - d. Set audio recording to Stereo;
 - e. Choose a good background, face the window instead and use it as a source of light;
 - f. Illuminate your face using a ring light or any source of light;
9. For videos that include minors, a consent form for each child signed by the parent or guardian is required to be submitted. Please see attached Enclosure No. 4 for the consent form.
10. Video format should be MP4 with 1080p or 720p resolution;
11. Recommended minimum specifications for videos:
 - a. File Format: MP4
 - b. Dimensions: 1920px x 1080px (16:9)
 - c. Orientation: Landscape
 - d. Frame Rate: 30fps
12. Regional Offices are requested to review handwashing jingle video entries in their respective region and submit the best jingle to the Central Office. **Only one entry per region** will be reviewed and received by BLSS-SHD which should be submitted to blss.shd@deped.gov.ph.
13. The deadline for submission of entries will be on or before **October 6, 2023**.
14. Submitted entries should include names of composers and everyone involved in the development of the handwashing jingle and video for proper attribution. Accomplished consent forms for minors should also be included in the submission.
15. The video file name shall include Region name where entry is from (E.g. Region 1_School Name_Handwashing Jingle Video);
16. The Top 5 Best Handwashing Jingles will be selected based on the following criteria:
 - a. Originality (40%)
 - b. Content and relevance to handwashing initiatives (25%)
 - c. Musicality (e.g. melody, arrangement, accompaniment) (25%)
 - d. Creativity (10%)

Annex C

Guidelines for the making of Commitment Videos of Each Region

1. Select representative/s from the Regional Office to read the commitment statement. This can be the Regional Director, Assistant Regional Director, and/or ESSD Chief, together with the Regional School Health Personnel;
2. The commitment statement will be in Filipino language;
3. The selected representative/s will read the following Video Commitment Spiel:

Kami, mula sa **DepEd Rehiyon/Region ____**, ay nangangako na mas lalong paiging ang implementasyon ng WASH in Schools Program sa aming mga paaralan para panatilihin ang malusog at masigla ang ating mga mag-aaral.
