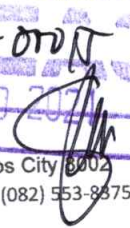

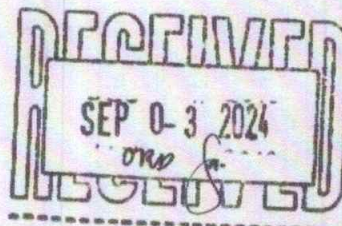

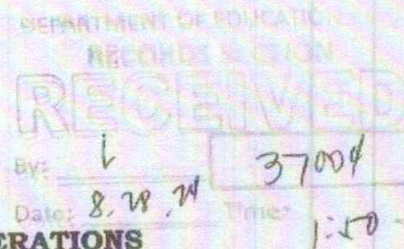

5. The first meal shall be served at **lunch** on the *first day* and ends with **morning snacks** on the *last day* of the event.
6. Participants will be billeted in the assigned venues mentioned above. The accommodation period begins on the *first day*, **check-in time** at **5:00 p.m.** and ends on the *last day* of the event, **check-out time** at **12:00 p.m.** Those who will arrive at the venue earlier and/or extend the prescribed dates shall be responsible for the costs of advanced/extended booking for lodging.
7. Any other additional expenses incurred while at the venue, such as long-distance phone calls, personal meal orders outside the venue, and so on, will not be covered by the organizers and must be paid for by the participant/s.

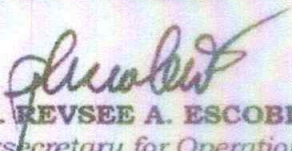
