The same commemorates the adoption of the United Nations Convention on the Rights of the Child (UNCRC) to serve as a reminder for duty-bearers to promote and protect children's rights.

Relatedly, the Department of Education (DepEd), through the Learner Rights and Protection Office (LRPO), joins the Council for the Welfare of Children (CWC), the National Youth Commission (NYC), and the Department of Social Welfare and Development (DSWD), local government units, and private organizations including the civil society, private enterprises, and nongovernment and civil organizations in celebrating the 32nd National Children's Month (NCM) with the theme, *Break the Prevalence, End the Violence: Protecting Children, Creating a Safe Philippines!*

As we conclude this year's celebration, we hope to inspire and re-ignite our advocacy of safeguarding our learners' rights as well as creating a safe and positive learning environment for all. To this end, we hope to invite the Regional and Assistant Regional Directors or their authorized representatives, the Education Support Services Division Chief or their authorized representatives, Regional permanent and alternate focal personnel, including identified division focal personnel, school heads, and registered guidance counselors/designates. The discussion shall include the importance of fulfilling the roles and responsibilities of the LRP Specialists in handling all forms of abuse, exploitation, neglect, violence, and bullying of our learners, equipping them with adequate knowledge and skills imbued with attitudinal orientation to discharge their responsibilities of providing learners with appropriate protective services². Further, with the LRPO's desire to train more LRP specialists in the field, we request the Regional Office to identify regional/division focal personnel, school heads, and registered guidance counselors or designates who have yet to undergo the specialization course.
