GUIDELINES FOR PARTICIPATING STUDENTS IN THE VIRTUAL ENERGY QUIZ BEE

REQUIREMENTS

1. A reliable internet connection which can support the whole duration of the competition
2. A Personal Computer/Desktop or a Laptop with a camera, headset with a microphone
3. A Whiteboard (30x40cm), marker, bond papers and pens
4. A Zoom App - installed in your desktop or laptop (instruction on how to download the app is provided in the last part of this guideline)
5. Participants shall wear their complete school uniform and school ID. If school uniform is not available, the participant may wear a plain white shirt.
6. A half-body portrait picture of the student-participant while wearing their school uniform and ID, to be used in the promotional materials of the Virtual Energy Quiz Bee Competition.

PARTICIPANT QUALIFICATIONS

1. The 2024 Mindanao-wide Virtual Energy Quiz Bee Competition of the Department of Energy – Mindanao Field Office is open to all Grade 11 and Grade 12 Senior High School students currently enrolled under the Science, Engineering, Technology and Mathematics Strand.
2. The participants must be currently enrolled in a public school based in the following regions in Mindanao:
 - a. Region IX (Zamboanga Peninsula);
 - b. Region X (Northern Mindanao);
 - c. Region XI (Davao Region);
 - d. Region XII (SOCCSKSARGEN Region); and
 - e. Region XIII (CARAGA Administrative Region).
3. The participants should be officially enrolled this S.Y. 2024-2025 in the public school they are representing.
4. The participants must be able to meet all the requirements stated above and must be able to submit their Contestant Application Form, Certification and Endorsement, and Data Privacy Notice and Consent Form **on or before Friday, November 15, 2024**, unless otherwise decided by the Department of the Department of Energy – Mindanao Field Office due to exigent circumstances.
5. The participants must be represented by one (1) coach, who must be a faculty member of the school which the contestant is representing.

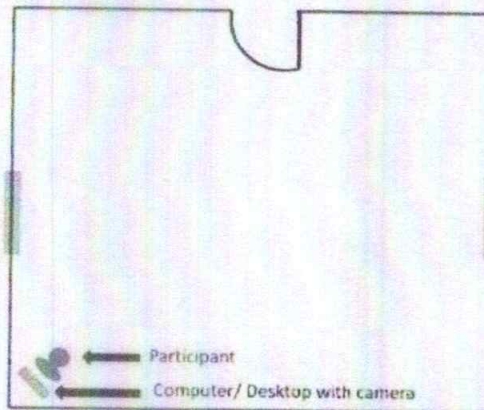


Figure 1: Sample Location of the Participant

4. Participants must always be facing their cameras throughout the competition, ensuring that the upper half of their body remains visible.
5. Under no circumstances should the participants turn off or set their microphones on mute.
6. Once the Virtual Energy Quiz Bee begins, participants are prohibited from leaving their private rooms unless official breaks are announced by the Quiz Master.
7. In case of an internet disconnection of the participant, a grace period of one (1) minute will be provided for reconnection. Once the said allotted time has lapsed, the Quiz Master will immediately proceed to the Quiz bee proper. The disconnected participant/s upon reconnection may opt to continue to participate for the remaining questions.
8. In unforeseen circumstances such as power outages or interruptions, participants may be permitted to utilize a mobile phone or tablet equipped with a camera, audio, and microphone (headset/earphones) and ensure a stable internet connection to continue participating in the competition.
9. Non-compliance to the rules and committing any form of cheating would result to automatic disqualification from the competition.

HOW TO INSTALL THE ZOOM APP

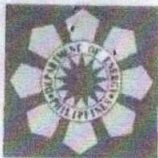
Method 1:

1. Open downloaded zoom app.
2. Click join.
3. Enter the Meeting ID (to be provided later).
4. Type School Name Initials followed by your name, example DCNHSSHS_JuanDelacruz.
5. Click join.
6. Enter the Meeting Passcode.
7. And click Join Meeting.

Method 2:

1. Click or copy to browser the Zoom Meeting Link provided.
2. Select Launch Meeting.
3. Select Open in zoom meetings on the pop-up window.
4. Enter the Meeting Passcode.
5. And click Join Meeting.

13. The top ten (10) highest scorers from the Preliminary Round shall compete in the Final Competition.
14. For the preliminary competition, the participant with the highest cumulative score will be declared as the First Place. The next two highest-scoring participants will earn the titles of Second Place and Third Place, respectively.
15. For the final competition, the participant with the highest cumulative score will be declared as the Champion. The next two highest-scoring participants will earn the titles of first runner-up and second runner-up, respectively.
16. The organizers reserve the right to change all rules and guidelines for this event without prior notice.

PRIZES

A. Preliminary Competition

- *First Place – Certificate of Participation and cash prize amounting to P6,000.00
- *Second Place - Certificate of Participation and cash prize amounting to P4,000.00
- *Third Place - Certificate of Participation and cash prize amounting to P2,000.00
- *Consolation Prizes - Certificate of Participation and cash prize amounting to P1,000.00 for each non-winning participant
- *Honorarium for the Coaches - Certificate of Appreciation and cash amounting to P1,000.00 per coach

B. Final Competition

HOUSE RULES

1. The rules and mechanics must **BE STRICTLY OBSERVED** on the day of the Virtual Energy Quiz Bee.
2. Use of any electronic gadgets, applications (besides the Zoom platform), written formulas and the like during the Virtual Energy Quiz Bee is **STRICTLY PROHIBITED**. *(The participants may be allowed to use a scientific calculator for computation purposes. Kindly wait for additional instructions.)*
3. Throughout the Preliminary Competition, participants must be seated at the corner area of a private, quiet, and undisturbed room (see Figure 1). No other individuals are allowed in the designated room besides the participant themselves. Prior to the competition proper, the proctors shall check the 360-degree view of the participants, to ensure compliance to this house rule.

MECHANICS

1. The Virtual Energy Quiz Bee has three rounds: EASY, AVERAGE, and DIFFICULT. The duration for answering will vary based on the question. Below are the corresponding number of items and points per correct answer.

ROUND	NUMBER OF ITEMS	POINTS PER CORRECT ANSWER	TOTAL POINTS
EASY	10	1	10
AVERAGE	10	3	30
DIFFICULT	10	5	50

2. Incorrect, incomplete and misspelled answers, including unanswered items, shall not be given a corresponding point or credit. Additionally, participants shall adhere to proper capitalization and the inclusion of accent marks, hyphens, or spaces in a word, and avoid using abbreviations or acronyms, unless specified in the question.

3. Questions will be based on but not limited to the following areas/topics:
- Renewable Energy Resources and Technologies: Biomass, Geothermal, Solar, Hydropower, Ocean and Wind (BiGSHOW)
 - Non-renewable Resources: Coal, Natural Gas, Oil, and Nuclear Energy
 - Energy Efficiency and Conservation
 - Basic Power System
 - Liquid Fuels and Liquefied Petroleum Gas (LPG) including safety and conservation
 - Other issues and information related to energy and the Department of Energy

4. Each participant must utilize either a desktop or laptop with a stable internet connection. The camera and microphone must be open throughout the competition.

5. Each participant is required to have a whiteboard and marker for answering, along with bond papers and pens for problem-solving purposes.

6. At the onset of the Easy Round, every participant begins with a score of zero. Points accrued during the competition will accumulate cumulatively across all rounds.

7. The Quiz Master will read each question twice. Questions will be displayed using a PowerPoint presentation and should be pinned by all participants in the Zoom room.

8. Participants must await the Quiz Master's "GO" signal before responding to any questions.

9. At the end of the allocated time, participants will be prompted to display their answers by raising their boards to their cameras. Boards should only be presented or lowered as directed by the Quiz Master.

10. Participants may address questions or contest answers during the Quiz Bee. In case of dispute, participants should raise their concerns to the Quiz Master, who will refer the matter to the Board of Judges. Any inquiries or protests must be made before the next question is presented to be considered valid. The Board of Judges' decisions are conclusive and final.

11. At the end of the Average and Difficult Rounds, the participant with the highest cumulative score will be declared as the Champion. The next two highest-scoring participants will earn the titles of first and second runners-up, respectively.

12. In the event of a tie, a Clincher Round will be initiated, continuing until one participant solely gets the correct answer, breaking the tie.
