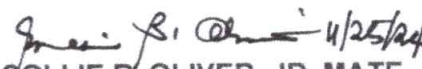

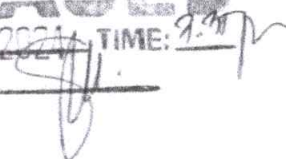

The year is about to end and we wish to take this opportunity to express our appreciation for your continued support to the Fund and for our fruitful partnership through the years.

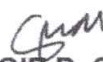
