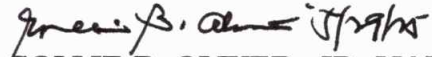

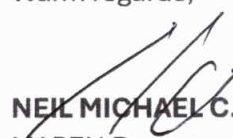
Greetings of good health and service!

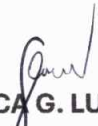
