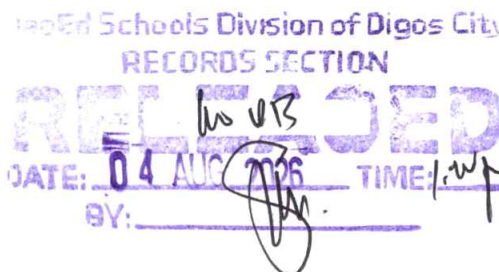

In accordance with DepEd Order No. 009, s. 2026, titled "Guidelines on the Implementation of the Three-Term School Calendar in Basic Education," participation shall not disrupt classes. The scheduled instructional block must not be disturbed, and related activities shall be conducted only outside instructional time. No government funds shall be spent for this activity.
